# Business Brokerage and Merger and Acquisition Practices

What are the differences and in 2019 what are the choices for business owners planning to sell their companies?

Over the last four decades, Business Brokerage has become very much more professional and differences now, between lower-middle-market M&A firms and business brokers, have largely disappeared.

While the process of facilitating the sale of privately held smaller companies has evolved to the point where it is often similar whether the business is grossing \$50,000 or \$50,000,000, there are a number of different types of firms. These practitioners in business brokerage today in 2019 might be summarized as follows:

#### 1) Real Estate Brokers

In less populated areas, this group dominates since there is usually no other resource for the business owner. Real Estate agents often have little training, in the sale of businesses and the methodology is more akin to selling a house – the least like M&A practices of any group. In metro areas many of the larger, well-known real estate companies prohibit their agents from selling businesses because their errors and omission insurance don't cover business sales.

#### 2) Franchised Business Brokers

There are many hundred of business broker franchises throughout the US. Most are small (1-3 associates) and many use a work-at-home model. The franchisees are only loosely affiliated and tend to work independently of each other which tends to limit their reach. In many areas of the country, especially in California, co-brokering is discouraged, i.e., a listing agent will refuse to provide information to another agent who might have a buyer making it difficult-to-impossible for that agent to help his client.

Various professional organizations such as the IBBA (International Business Brokers Association) and CABB (California Business Brokers Association), understanding that such a real estate approach is not in the client's best interest, have attempted to change this attitude with no success. (One of the main reasons that multiple listing services (MLS) have dominated the residential market for so long is that they compel their members to share information and thereby make co-brokering effective).

#### 3) Business Broker / M&A professional firms with 50+ associates

These associates all work for the same company and usually cover a large geographic region with a number of offices. Unlike the franchise model in which the franchisor has little control, the associates in the company-owned offices are required to adhere to company standards and most importantly must

facilitate co-brokering with each other which creates, in effect, an MLS service.

This is similar to the approach used by the large regional and national commercial real estate firms. As with MLS, associates in these larger brokerages have large inventories enabling them to better match a buyer's interests. Most importantly, associates can access pertinent information directly. Business sellers benefit from more competition from a larger pool of buyers.

Each of these three categories offering business brokerage / M&A services has its place and the business owner's choice of a broker will depend upon business value, locale, relationships and advisor referrals.
